### Official Rules & Regulations

- 1. Eligibility:** This Sunseeker Resort Spring Training Sweepstakes –The Ultimate Spring Training Escape Getaway (the “Promotion”) is open to persons who are legal residents of the 50 United States and the District of Columbia (the “Territory”), are age twenty-one (21) years or older and located in the Territory at the time of entry, and who have an active email address. A purchase does not increase chances of winning. To enter, follow the on-screen directions, complete all required registration fields, check the box to accept these Official Rules, and submit to enter (the “Entry”). Limit one (1) Entry per person and per email address for the entire Promotion Period. Entrants must complete all required information to be eligible. The Entry must fulfill all Promotion requirements, as specified herein, to be eligible to win a prize (“Prize”). Entries that are incomplete or do not adhere to these Official Rules or specifications may be disqualified at the sole discretion of Sponsor. Multiple entries from the same person or email address

beyond the stated limit will be void.

There will be one (1) total winner (collectively the “Winner”).

There will be one (1) Winner. Prize must be accepted as awarded. All Prize components must be used in their entirety within one (1) year from the date of Winner notification; unused portions will be forfeited. Prize is subject to availability and blackout dates as determined by Sponsor. Airfare, ground transportation, and travel to and from the resort are not included.
